

END USER LICENSE AGREEMENT (EULA)

CyberMetrics Corporation (“CyberMetrics”) makes this software and all extensions, updates, supplements, internet-based services, and support services related to the GAGetrak suite of platform and cloud services (collectively, the “Software”) available to you as an end user (“you”, or “your”) for your use subject to the terms and conditions in this End User License Agreement (the “Agreement”). BY USING THIS SOFTWARE, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS OF THE AGREEMENT, YOU MAY NOT USE THE SOFTWARE AND MUST DELETE ANY DOWNLOADED OR ELECTRONIC COPIES THEREOF AND RETURN ANY RELATED PHYSICAL MEDIA (including written materials and binders or other containers) TO THE PLACE FROM WHICH YOU OBTAINED THEM FOR A FULL REFUND.

IMPORTANT NOTICE: YOUR USE, ACCESS, DOWNLOAD, AND/OR RECEIVING OF ANY OF CYBERMETRICS SOFTWARE IS SUBJECT TO AN ARBITRATION PROVISION IN SECTION 11 OF THIS AGREEMENT, REQUIRING ALL CLAIMS TO BE RESOLVED BY WAY OF BINDING ARBITRATION, UNLESS PROHIBITED BY LAW OR YOU EXPRESSLY OPT OUT OF ARBITRATION AS DESCRIBED IN THAT SECTION.

1. **CyberMetrics Rights in Materials.** CyberMetrics Software, services, and any and all other information, data, documents, materials, works and other content, devices, methods, processes, hardware, software and other technologies and inventions, including any technical or functional descriptions, requirements, plans, specifications, or reports, that are provided or used by CyberMetrics or any subcontractor engaged by CyberMetrics in connection with the Software, the designs of each of the foregoing, and any and all intellectual property rights in the foregoing (collectively, the “CyberMetrics Materials”) shall at all times remain the exclusive property of CyberMetrics and its third-party licensors. Any third-party software included in the Software is licensed subject to the additional terms of the applicable third-party license.

2. **Grant of License.** Subject to the terms and conditions of this Agreement, CyberMetrics hereby grants to you a revocable, non-exclusive, non-transferable, limited right and license, during the applicable License Period (as defined below), to: (a) install and use the Software in executable form only on your servers and workstations at the authorized site(s), only for your internal business purposes, and subject to the number of service locations and user licenses specified in the applicable sales order; (b) make one (1) copy of the Software solely for backup or archival purposes; and (c) copy and reproduce the documentation provided to you solely for the purposes of facilitating your use of the Software. CyberMetrics reserves all rights not otherwise expressly granted by this Agreement. Any use of the Software that exceeds the rights expressly granted in this Agreement is strictly prohibited and constitutes a violation of this Agreement, which may result in the termination of your license to use the Software. You are not acquiring any rights in or to the CyberMetrics Materials other than a non-exclusive license to use the Software solely in accordance with the terms of this Agreement.

3. **License Period.** The duration of the license set forth in Section 2 above (the “License Period”) shall be as follows, in accordance with the type of license purchased pursuant to the applicable sales order. If you purchased a subscription license, the grant of license shall apply only to this version of the Software, and the License Period shall begin on the start date of the subscription and expire after the amount of time set forth on the applicable sales order. However, if you purchased a perpetual license, the grant of license shall apply only to this version of the Software, and the License Period is not limited in term, but extends indefinitely, provided you do not otherwise violate the terms of this Agreement or the applicable sales order.

4. Modification. CyberMetrics may alter any aspect of the Software at CyberMetrics sole discretion and without prior notice or liability to you. CyberMetrics may also install bug fixes, updates, patches, and other upgrades to the Software without prior notice or liability to you. Your only remedy is to discontinue using the Software if you do not want a modification we make to the Software.

5. Removal Of Access. You agree that CyberMetrics may immediately suspend or terminate your access to the Software or any part thereof. Cause for such measures includes, without limitation: (1) breach or violation of this Agreement or other incorporated agreements or guidelines; (2) unexpected technical or security issues or problems; or (3) your engagement in fraudulent or illegal activities. You further agree that such measures may be taken in our sole discretion and without liability to you or any third party.

6. Other Restrictions. You may not: (1) license, sublicense, sell, resell, transfer, assign, distribute, or otherwise commercially exploit or make available to any third party any portion of the Software in any way; (2) copy, modify, adapt, alter, translate, create derivative works, reverse engineer, decompile, disassemble, or otherwise attempt to learn the source code, structure, or ideas upon which the Software is based; (3) use the Software or CyberMetrics Materials to develop a competing service or product; (4) use any device, software, or routine intended to damage or otherwise interfere with the proper functioning of the Software or take any other action that interferes with any other person's use of the Software; (5) use or merge the Software or any component thereof with other software, databases, or Software not provided or approved by us; (6) circumvent or attempt to circumvent any electronic protection measures in place to regulate or control access to the Software; (7) use the Software for unlawful purposes; (8) develop, distribute, or sell any software or other functionality capable of launching, being launched from, or otherwise integrated with the Software; (9) use any bot, spider, or other automatic or manual device or process for the purpose of harvesting or compiling information on the Software for any reason; (10) use any CyberMetrics Materials made available through the Software in any manner that misappropriates any trade secret or infringes any copyright, trademark, patent, rights of publicity, or other proprietary right of any party; (11) introduce into the Software any virus, rogue program, Trojan horse, worm or other malicious or intentionally destructive code, software routines, or equipment components designed to permit unauthorized access to or disable, erase, or otherwise harm the Software, or perform any such actions; (12) introduce into the Software any back door, time bomb, drop dead device, or other software routine designed to disable a computer program automatically with the passage of time or under the positive control of an unauthorized person; (13) delete, modify, hack, or attempt to change or alter the Software, CyberMetrics Materials, or notices on the Software; (14) connect to or access any CyberMetrics computer Software or network other than the Software; (15) impersonate any other person or entity to use or gain access to the Software; or (16) obscure or remove any proprietary rights notices contained in or on the CyberMetrics Materials. We reserve the right to investigate and prosecute violations of any of the above to the fullest extent of the law. We may involve and cooperate with law enforcement authorities in prosecuting users who violate this Agreement.

7. Representations. You hereby represent and warrant that: (1) you (a) are over the age of 18; and (b) have the power and authority to enter into and perform your obligations under this Agreement; (2) all information provided by you to us is truthful, accurate and complete; (3) you will comply with the terms and conditions of this Agreement and any other agreement to which you are subject that is related to your use of the Software or any part thereof; (4) your use of the Software or any part thereof will not constitute a breach or violation of any other agreement, contract, terms of use or any law or regulation to which you are subject; (6) you will not use the Software in order to gain competitive intelligence about us, the Software, or any product or service offered via the Software or to otherwise compete with us; and (8) you will employ all physical, administrative, and technical controls, screening and security procedures, and other safeguards necessary to securely administer the use of the Software, and protect against any unauthorized access to or use of the Software.

8. Refund. You may return the Software and all accompanying written materials, for any reason, for a full refund, for a period of 30 days from the date you first receive the Software.

9. DISCLAIMER. TO THE MAXIMUM EXTENT PERMITTED BY LAW, THE SOFTWARE IS PROVIDED "AS IS" AND "AS AVAILABLE," AND USE OF THE SOFTWARE IS AT YOUR SOLE RISK. TO THE MAXIMUM EXTENT PERMITTED BY LAW, WE EXPRESSLY DISCLAIM ALL WARRANTIES OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR USE OR PURPOSE, TITLE, AND NON-INFRINGEMENT. WITHOUT LIMITATION, WE MAKE NO WARRANTY THAT THE SOFTWARE WILL MEET YOUR REQUIREMENTS, THAT USE OF THE FOREGOING WILL BE UNINTERRUPTED, TIMELY, SECURE, OR ERROR-FREE, THAT THE RESULTS OBTAINED FROM THE USE OF THE FOREGOING OR ANY INFORMATION OR CONTENT FOUND ON THE SOFTWARE WILL BE ACCURATE OR RELIABLE, THAT DEFECTS IN THE OPERATION OR FUNCTIONALITY OF THE SOFTWARE WILL BE CORRECTED, THAT THE SOFTWARE AND ANY CONTENT OR INFORMATION FOUND ON THE SOFTWARE WILL BE VIRUS-FREE, OR THAT THE QUALITY OF ANY INFORMATION, CONTENT, OR OTHER MATERIALS OBTAINED THROUGH THE SOFTWARE WILL MEET YOUR EXPECTATIONS. BECAUSE SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF LIABILITY FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES, THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

11. Arbitration. If you and CyberMetrics are unable to resolve a dispute through informal negotiations, either you or CyberMetrics may elect to have the dispute (except those disputes expressly excluded below) finally and exclusively resolved by binding arbitration. Any election to arbitrate by one party shall be final and binding on the other. The arbitration shall be commenced and conducted under the Commercial Arbitration Rules of the American Arbitration Association ("AAA") and, where appropriate, the AAA's Supplementary Procedures for Consumer Related Disputes ("AAA Consumer Rules") both of which are available at the AAA website www.adr.org. The determination of whether a dispute is subject to arbitration shall be governed by the Federal Arbitration Act and determined by a court rather than an arbitrator. Your arbitration fees and your share of arbitrator compensation shall be governed by the AAA rules and, where appropriate, limited by the AAA Consumer Rules. The arbitration may be conducted in person, through the submission of documents, by phone or online. The arbitrator will make a decision in writing, but need not provide a statement of reasons unless requested by a party. The arbitrator must follow applicable law, and any award may be challenged if the arbitrator fails to do so. Except as otherwise provided in this Agreement you and CyberMetrics may litigate in court to compel arbitration, stay proceeding pending arbitration, or to confirm, modify, vacate or enter judgment on the award entered by the arbitrator.

12. Miscellaneous. This Agreement is effective upon your acceptance and will continue in full force until terminated by you or CyberMetrics. You may terminate this Agreement at any time by immediately discontinuing all use of the Software. Termination or cancellation of this Agreement will not affect any

right or relief to which CyberMetrics may be entitled at law or in equity. CyberMetrics reserves the right to terminate this Agreement at any time and for any reason without prior notice to you. You understand and expressly agree that you and CyberMetrics are independent contractors and not agents or employees of the other party. Neither you nor CyberMetrics has any right, power, or authority to act or create any obligation, express or implied, on behalf of the other party. You agree not to contest the authorization for, or validity or enforceability of, electronic records and electronic signatures, or the admissibility of copies thereof, under any applicable law relating to whether certain agreements, files, or electronic records are to be in writing or signed by you to be bound thereby. You agree that breach of the provisions of this Agreement would cause irreparable harm and significant injury to CyberMetrics which would be both difficult to ascertain and which would not be compensable by damages alone. As such, you agree that CyberMetrics has the right to enforce the provisions of this Agreement by injunction (without necessity of posting bond), specific performance, or other equitable relief without prejudice to any other rights and remedies CyberMetrics may have for your breach of this Agreement. CyberMetrics may revise and update this Agreement from time to time and will post the updated Agreement to the portal. UNLESS OTHERWISE STATED IN THE AMENDED VERSION OF THIS AGREEMENT, ANY CHANGES TO THIS AGREEMENT WILL APPLY IMMEDIATELY UPON POSTING. Your continued use of the Software will constitute your agreement to any new provisions within the revised Agreement. CyberMetrics failure to enforce any provision of this Agreement will not be deemed to be a waiver of its right to enforce them. If any term or provision of this Agreement is held to be invalid, illegal, or unenforceable, the remaining terms and provisions of this Agreement will remain in full force and effect, and such invalid, illegal, or unenforceable term or provision will be deemed not to be part of this Agreement. You may not assign, transfer, or sell (voluntarily or by operation of law) your rights or obligations under this Agreement, nor delegate your duties hereunder to any other person, without CyberMetrics' prior written consent. The provisions of this Agreement that by their content are intended to survive termination of this Agreement will survive termination of this Agreement.
